The President's Message

As a morning walker, this is the time of year when I am not sure about the season. Morning light is returning and at 7:15 a.m. we are no longer walking in the gloom of pre-dawn. At the same time, the mornings have been cold. We were surprised this morning at the slickness of the roads from just a little overnight moisture and temperatures in the 20s. We made it without falling, though we walked a little slower.

I have been reading <u>The Good Ancestor</u> by Roman Krznaric, published in 2020. The basic premise of the book is that we are here in this place because we had good ancestors who did the "right" things so that we could be alive and in this place. The question is what should we as individuals, communities and countries be doing so that our descendants will have a good space in which to live. The book then walks the reader through multiple ways to be long-term thinkers and planners. The surprise is that here "long-term" means more than our lifetime or even the lifetimes of our children and grandchildren. Instead, we should be planning for the 7th generation.

As I thought about this, I realized that for many of my familial lines, I am a 7th generation American. My ancestors left their homes and crossed the sea, established farms, fought in wars, established businesses, taught in schools, and raised families in various Maryland and Pennsylvania communities. Because of them, I am here and have had a wonderful life with many opportunities and experiences.

In a similar fashion, women in this country fought for the right to vote and established various societies and organizations, like the AAUW, to support each other and promote the common good. The suffragettes endured many hardships to secure our rights and, I hope, the rights and opportunities of women unto the 7th generation and beyond. If you go by my family, it takes about 200 years to reach the 7th generation. So, what will America and the world look like for women 200 years from now?

I am no fortune-teller. All I can do is be thankful for those who went before and those who walk beside me now. I can support efforts to make the ERA part of the Constitution and continue to support the efforts of the AAUW to secure education, equal pay, and equal opportunities for women. In addition, I can plant acorns, but that is a story for another day.

I hope you had a chance to comment on National's proposed changes for dues, the by-laws and the public policy priorities. I thought an increase of \$5 per year each year for the next five years was a bit much. The comment period has expired but I imagine a vote will be asked for soon. Please keep checking your emails.

Our Founders Day luncheon is right around the corner, and I hope to see you there. We can talk about acorns and the legacy we would like to leave for the women of Washington County.

Public Policy Update

Maryland AAUW shared this information about the bills they are supporting during the 2025 session of the Maryland General Assembly:



In November, leaders of state-wide organizations, legislators, and advocates addressing issues of concern to women of Maryland participated in a conference to identify potential legislative initiatives for the 2025 Maryland General Assembly. Fourteen bills were presented at the conference for consideration. A ballot was sent to MLAW members who voted on the top priorities which will make up our official 2025 Legislative Agenda.

The bills selected for MD AAUW support are:

- Stop Silencing Survivors
- Firearm Relinquishment and Victim Notification
- Abortion Care Access Fund Act of 2025
- Correctional Services-Comprehensive Rehabilitative Prerelease Services-Female Incarcerated Individuals
- Prescription Drug Affordability Board Act
- Universal Newborn Nurse Home Visiting Services Program and Coverage
- Corrections Segregated Housing Limitations
- Protecting Nursing Home Quality Care
- Birth Certificate Modernization Act
- Young Adult Health Insurance Subsidies Pilot Program Sunset Repeal

Recipe of the Month

<u>Irish Soda Bread Muffins</u>

A tasty addition to your March 17 corned beef and cabbage

2 ¼ C flour 1 large egg, room temperature

½ C plus 1T sugar, divided1 C buttermilk2 t baking powder¼ C butter, melted½ t salt¼ C canola oil

1 t caraway seeds

- 1. Combine flour, ½ C sugar, baking powder, salt, baking soda and caraway seeds. In a bowl, whisk egg, buttermilk, butter and oil. Stir into dry ingredients just until moistened. Fold in currants.
- 2. Fill greased muffin cups three-fourths full. Sprinkle with remaining sugar. Bake at 400 degrees until a toothpick inserted in the center comes out clean, 13-15 minutes. Cool 5 minutes before removing.
